- Federal Radon Action Plan (FRAP) transition to the National Radon Action Plan (NRAP)
- State Cancer Coalitions/ Cancer Control Plans
- ICC codes changes for RRNC
- RRNC adoption by State/local building codes
- Continue collaborating with/investing in national partners [CRCPD, ALA, ELI, NCSL, KSU, WHO]

#### FY 2015 SIRG Program

- Congress authorized \$8.051 Million
  - \$7,730,000 to 45 States
    - Non-participating States (NH, HI, MD, LA, AR)
  - \$321,000 to 9 Tribes in Regions 1, 5, 6 and 10
- AARST and partners instrumental in restoring SIRG funding

#### Office of Inspector General Report

- IED has certified the completion of all corrective actions specified in the report
- IED study of device accuracy determined they provide accurate and reliable results (2014)
  - Further evidence that short-term measurement devices are OK for making mitigation decisions
  - http://www.epa.gov/radon/pubs/index.html
  - Included in our FAQs on the IAQ website

#### National Indicators of Progress

- Lives saved (LS): mitigation and home building [Calendar 2013 Latest Data Available]
- Homes mitigated (fan driven systems)
  - 807 LS from 112,165 mitigated homes
  - 9,100 LS from 1,245,000 *mitigated* homes (1986-2013)
- Homes built RRNC (passive & active)
  - 15.4% Single-family units (2012 234 LS)
  - 24.3% Multi-family units
